AS A PRIMARY PROGRAM, BUCKEYE PVA CONTINUES TO WORK CLOSELY WITH OHIO VAMC'S IN CLEVELAND, CINCINNATI, DAYTON AND CHILLICOTHE TO FORM A TEAM THAT PROMOTES OUR MEMBERS' HEALTH (BOTH MENTAL AND PHYSICAL) AND INTERESTS. IT ALSO CREATES A BOND FOR FAMILIES OF OUR MEMBERS AS MANY FAMILIES NETWORK AND SOCIALIZE AT THE SPORTING EVENTS. ONE OF OUR GOALS IS TO INCREASE MEMBERS' SKILLS SO THEY CAN GET INVOLVED IN INDIVIDUAL AND COMMUNITY ACTIVITIES, SPORTING EVENTS AND PVA SPONSORED EVENTS.
